

## **Privacy Information (UE) n. 679/2016 (“GDPR”)**

This Policy is aimed at illustrating the methods and purposes of the processing of personal data by "Mimmo Rome tours", with registered office in Rome, Giuseppe Mimmo – Via Enrico Stevenson 24 00162, as data controller (hereinafter referred to as " Owner "), through the website [www.mimmorometours.com](http://www.mimmorometours.com) and for the purpose of managing and executing the contractual requests in place with the Interested parties.

The processing of personal data of users connected to the web services of the site will take place exclusively in Italy, in full compliance with the current legislation on the protection of personal data (EU Regulation 679/2016).

### **THE SITE**

The Site is configured in such a way as to minimize the collection and use of user identification data, excluding processing in all cases in which the set purposes can be achieved by other means.

Please note that this Policy must be considered referring and applicable only to the Site, without extending to pages or sites accessible through links and / or managed by third parties.

Therefore, users are invited to read the relative privacy policy, for a more detailed understanding of the processing carried out through these third-party websites.

### **PURPOSE OF THE TREATMENT**

Personal data are processed by the Data Controller within the limits and for the sole purpose of providing services and / or creating products, in particular for:

- respond to requests sent by users by sending e-mail;
- carry out preliminary activities as a result of requesting information and contacting and / or sending informative material, as well as for the fulfillment of any other obligations arising;
- the management of an order, the provision of a Service and / or the production of a Product, the related invoicing and management of the payment as well as the fulfillment of any other obligations arising;
- As part of the provision of services for registering a domain name, personal data, for purposes strictly related to the provision of the service, will be communicated to third parties (Aruba Business SpA and / or Registration Authority and related accredited subjects) which are based in

EU countries or for which an adequacy provision on the level of data protection by the European Commission is in force.

- In addition, the interested party is informed that registration of a domain name entails the insertion of personal data into a publicly accessible register.

("Whois") kept at the Registration Authority responsible for the chosen extension, except in cases where the interested party has requested the obscuring of personal data in the manner provided by the competent Registration Authority or the contractual conditions relating to the Service.

- In the exclusive scope of the provision of the service for the creation and management of an Internet site, Mimmorometours is implicitly authorized to use the personal and authentication data (user name, password ...) relating to Hosting Services, access to Database, access to restricted areas or anything else indispensable for the performance of what is contractually defined.

## TYPES OF DATA PROCESSED

Data provided voluntarily by the user

The optional, explicit and voluntary sending of any personal data by the user, such as name, surname or e-mail address, involves the subsequent acquisition of the sender's address, necessary to respond to requests received.

The collection and processing of additional personal data (address, province and municipality, landline and / or mobile phone, fax, Fiscal Code, VAT number) is necessary to follow up the requested services as well as the provision of the Service and / or supply of the requested Product. If the Data Subject does not provide the personal data expressly provided for as necessary in the order document, the Data Controller will not be able to process the processing of the requested services and / or the contract and the Services / Products connected to it; nor to the obligations that depend on them.

Mimmorometours does not require the Data Subject to provide data c.d. "Particulars", that is, according to the provisions of the GDPR (Article 9), personal data revealing racial or ethnic origin, political opinions, religious or philosophical convictions, or union membership, as well as genetic data, data biometrics designed to uniquely identify a natural person, data relating to a person's health or sexual life or sexual orientation.
